

# Application for Outdoor Lighting Service

The undersigned, (hereinafter called "Member"), applies for outdoor lighting services from Volunteer Energy Cooperative, (hereinafter called "Cooperative" or "VEC"). At the premises located at the address shown below, upon the following terms and conditions, hereby agrees: (1) To comply with and be bound by the articles for incorporation, the bylaws, rules and regulations, and policies of the Cooperative now in effect and as may, from time to time, be amended; (2) when electric energy becomes available, to purchase from the Cooperative all electric energy received; (3) that this instrument grants to the Cooperative an easement or rights-of-way over, on and under any property of the Member within the Cooperative's service area as provided in the Cooperative bylaws; (4) to obtain a grant of easement from any person or entity having any interest in property of Member; (5) to pay any and all expenses incurred by the Cooperative, including attorney's fees and court costs, for enforcement of any of the provisions of the application by the Cooperative; (6) upon acceptance of the application by the Cooperative, same shall constitute an agreement and contract, subject to being cancelled by either party in accordance with the bylaws and rules and regulation of the Cooperative.

Lamp is open type hooded luminary to be operated from dusk to dawn.

Condition of service: The Cooperative will furnish all necessary equipment and maintain equipment including replacement of lamps and electric energy to operate lamp. All maintenance shall be performed during working hours as soon as practical. The Member shall be held financially responsible for intentional and avoidable damage or destruction of Cooperative property as described above. Billing will be paid monthly at rates to be determined in accordance with the rules and regulations of the Cooperative. The term of the contract for new installations shall be 36 months and shall continue thereafter until terminated by either party. The Member will be responsible for paying in full contracts terminated prior to 36 months.
