## Grandma Jones' Creamy Macaroni

### Ingredients:

12 oz of elbow macaroni  
8 oz of mild cheddar cheese (shredded)  
1 large egg  
1 cup of cottage cheese (any curd)  
2 tablespoons of dried chives  
paprika  
2 teaspoons of butter  
salt and pepper

Preheat oven to 325 degrees. Lightly grease 2 qt. baking dish. Cook macaroni until tender. Drain well and return to pan. Add and stir in butter-set aside. Whisk egg in large bowl. Add cottage cheese, sour cream, chives, salt and pepper, cheddar cheese. Toss all together gently. Add cooked macaroni. Toss again until fully mixed. Put into greased baking dish. Sprinkle with paprika. Cook about 45 minutes.

2 small boxes instant vanilla or banana pie and pudding mix  
3 cups of milk  
1-8 oz. Cool Whip  
1-16 oz. carton sour cream

With mixer, mix instant pie and pudding mix with milk. With spoon: mix Cool Whip and sour cream. Mix the 2 mixtures above and use vanilla wafers and bananas as in other banana pudding.

skim milk

fat free sour cream  
low fat vanilla wafers.

Levelized Billing uses a 12-month rolling average to calculate your bill. That removes the seasonal peaks and valleys in your electric bill and helps you anticipate and budget for your monthly electricity charges. If you don't like surprises when it comes to your electric bill, Levelized Billing is the way to go.

If you want to take the hassle out of paying your monthly electric bill, the Automatic Bank Draft Payment program is the right tool for the job. Save on postage, time, and trouble by having your electric bill automatically deducted from your bank account. It's quick and easy and a sure way to avoid late charges.

And from now until the end of the year, any customer who signs up for one or both of these services will receive a free jelly cell mate.
