

## **VEC** Helps Finance Cumberland House Hospice



USDA Rural Development State Director Mary "Ruth" Tackett joined VEC President/CEO Bill Buchanan for groundbreaking ceremonies for Cumberland House on June 6

Volunteer Energy Cooperative (VEC) recently joined forces with USDA Rural Development and the Crossville Housing Authority to finance Crossville House, a residential home for individuals diagnosed with terminal illnesses.

The home is being built by Hospice of Cumberland County, Inc. VEC secured a \$100,000 zero-interest loan to assist with the

project and the Crossville Housing Authority secured a \$30,000 USDA Rural Development grant to assist with the project.

Groundbreaking ceremonies were conducted June 6 and joining VEC President/CEO Bill Buchanan for the event were USDA Rural Development State Director Mary "Ruth" Tackett, Carolyn Jensen, field representative for U.S. Sen. Bill Frist, Lindsay Botts, field representative for U.S. Sen. Lamar Alexander, Sammy Lowdermilk, Beecher Frazier, field representatives for U.S. Rep. Lincoln Davis, Crossville Mayor J.H. Graham, Cumberland County Mayor Brock Hill, and Don Alexander, executive director of the Crossville Housing Authority.

"We are pleased to be able to help with this project," Buchanan said. "Through our economic development program, as well as through other resources at our disposal, VEC is here to assist with community development."

The 4,067 square-foot, six-bed residential hospice care facility will serve as a residential home for individuals diagnosed with terminal illness who choose to spend their final days at home, but who either lack or do not have a competent caretaker at home or a proper residence.



Volunteer Energy Cooperative (VEC) customers funded grants totaling \$33,900 in May. Since the inception of the program in October 2001, a total of \$1,442,365.20 in grants has been awarded.

Four high schools juniors from Volunteer Energy Cooperative's service area were among 114 Tennessee Students and about 1,800 students from across the country who attended the National Rural Electric Cooperative Association's 2005 Washington Youth Tour.

Each of the 114 students was rewarded with an Stephanie Lewis, and Ashley Logan. expense-paid trip to the nation's capital for writing

award-winning essays showing the benefits of cooperative power for the 2005 Washington Youth Tour Writing Contest, sponsored by Tennessee's electric cooperatives.

The topic for this year's contest was "Electric Cooperatives: Going Beyond the Wires." Students across Tennessee were invited to write short stories, no longer than 900 words, showing electric cooperatives' commitment to their communities – a commitment that goes beyond providing electric service.

In and around Washington, students were able to visit the historical places they had studied in school, including the homes of two of America's founding for a brief lavover before continu fathers: Thomas Jefferson's Monticello and George Washington's Mount Vernon. And they were able to see many of the famous Washington, D.C., landmarks including the Jefferson, Lincoln, World War II, Korean War and
