"Every year students across the state undergo the highly competitive selection process to earn a spot at the Youth Leadership Summit," said Joe Jackson, TECA director of youth and member relations. "Local electric cooperatives, along with school officials and guidance counselors, chose these outstanding students based on their interest in government and their leadership abilities."

"The annual summit gives students an opportunity to learn about electric cooperatives and how they affect their lives. Jackson said of the students representing 21 of Tennessee's electric cooperatives. "It also gives them an opportunity to see, in person, the legislative process in the Tennessee Capitol."

The summit was hosted by TECA and funded in part by the National Rural Utilities Cooperative Finance Corporation, a not-for-profit cooperative financing institute that provides an independent source of financing to member cooperatives nationwide. Volunteer Energy Cooperative (VEC) provided the funding for Erica to attend.

The summit kicked off Monday evening, March 17, with dinner at the group's hotel, the Millennium Maxwell House. "Get-acquainted" and leadership development activities followed, led by cooperative employees and special guests, including 2007 Miss Tennessee Grace Gore, and Tennessee Titans cheerleaders Kindle Martin and Lindsev Roznovsky.

Tuesday morning began early with breakfast and preparations for a visit to Legislative Plaza, TECA Director of Government and Public Affairs David Callis introduced State Rep. Doug Overby, who welcomed the students to Tennessee's capital and discussed the legislative process with them. Callis then explained current bills affecting cooperatives and described what everyone should expect from the legislative committees they were to visit.

The 11th-graders made their way to Legislative Plaza, where they got to see state government in action. Erica also met with State Senator Charlotte Burks.



Following the visit to Capitol Hill, the group enjoyed lunch and leadership activities at a Nashville-area YMCA camp. Later they made a quick stop for a pizza dinner before heading to watch a Nashville Predators hockey game followed by a tour of Nashville. The busy day was capped off with an ice cream social back at the hotel.

communities they serve. Then they fought it out in the "Energy Battle" competition, where teams answered trivia questions about electric cooperatives and the state.

"We offer these educational and leadership development experiences for our students — our future members — because we want them to understand what makes a cooperative special." said Robert McCarty, VEC communications coordinator who served as one of the chaperons and as a program presenter at the Youth Leadership Summit. "We also want to help prepare them to assume leadership roles in their communities."

Erica said she enjoyed the activities and programs.

"I especially enjoyed meeting and getting to know other students from across the state," she said. Erica is the granddaughter of Cherie McMurray of Ten Mile.

#### TVA ANNOUNCES April 1 Rate Hike

The Tennessee Valley Authority (TVA) has announced a rate increase and an increase in the Fuel Cost Adjustment that became effective on April 1. Volunteer Energy Cooperative (VEC) will be forced to pass these increases along to customers

but VEC will not add an increase of our own to the new rate structure. There will also be no increase in VEC's customer charge. These TVA increases will affect all rates and all classes of customers.

The percentage of the increases will vary depending on the amount of electricity consumed. For residential customers the increases amount to approximately 10%.

About 80 cents of every dollar VEC collects from customers goes directly to TVA and VEC has no choice but to pass the TVA increase through to customers. VEC will not add an increase of its own.

The TVA Fuel Cost Adjustment is itemized on VEC electric bills and is set each quarter by TVA. This is the difference between the amount TVA budgeted for fuel and the actual cost of the fuel. #### If you pay your VEC bill with the automated phone system, please note...

NACHA, the Electronic Payment Association, now requires that a PIN number be used for check payments made over the phone. Beginning soon you will be prompted to enter a PIN number when paying by check. For your VEC payments, this PIN number is the last four digits of your social security number. This change has been instituted to ensure that your checking account and its information are secure.

Here's a little sneak peek:

**Sugar Coated Pecans** 

- 1 egg white
- 1 pound pecan halves
- 1 tablespoon water
- 1 cup white sugar
- 1 teaspoon ground cinnamon
- 1 teaspoon salt



Preheat oven to 250 degrees. Grease one baking sheet. In a mixing bowl whip together the egg white and water until frothy. In a separate bowl mix the sugar, salt and cinnamon. Add pecans to egg whites. Stir to coat the nuts evenly. Remove the nuts and toss them in the sugar mixture until coated. Spread the nuts out on baking sheet. Bake at 250 degrees for 1 hour stirring every 15 minutes.
