

# VEC/TVA Residential Energy Services Program

## \*\*\*NEW HOME ENERGY BILL CREDIT\*\*\*

Volunteer Energy Cooperative and TVA join together to offer a \$50 credit on the VEC electric bill for builders of new energy efficient\* homes who make the all-electric choice. This one-time credit is available to the person who makes the building decisions during construction. To qualify, complete all information below, sign the form, and return it to your nearest Volunteer Energy Cooperative service center or mail to: VEC Marketing and Economic Development Dept., P.O. Box 277, Decatur, TN 37322. A TVA-qualified inspector will schedule a short visit to validate your home as an energy efficient\* all-electric home. Once the home is validated, the credit will appear on the electric bill in 6-8 weeks. If you have questions about this program, please contact your local VEC customer service center. **\*\*TO QUALIFY THE HOME MUST BE STICK-BUILT, ALL-ELECTRIC, AND LESS THAN 12 MONTHS OLD.**
