Custom Incentives

Custom incentives give you the flexibility to make energy improvements unique to your facility and operations and receive an incentive for it. Incentives are offered at a rate of up to \$0.10 per annual kWh saved for the installation of most technologies.



Forklifts/Non-Road EVs

Lift profitability and lower emissions with electric forklifts. Not only do they have lower operating costs-they're quieter and require less maintenance. We're offering incentives of \$2,000 toward the purchase of electric forklifts and \$1,000 toward an electric forklift lease when you replace gaspowered forklifts or expand existing electric fleets.



UVGI

Ultraviolet Germicidal Irradiation (UVGI) uses short wavelength UV-C light to inactivate microorganisms. UVGI is becoming increasingly popular across the globe, especially as a cost-effective alternative to chemical disinfection. TVA is offering an incentive of \$30 per ton for duct-mounted UVGI systems.



LED Lights

On top of using more energy, incandescent and fluorescent lights produce large amounts of heat. Upgrade your interior, exterior and street lighting to lower your energy costs. Making the switch to LED upgrades is more affordable with our incentives:

- \$0.08/kWh for indoor lighting
- \$0.04/kWh for exterior and street lighting




HVAC

HVAC (heating, ventilation and air conditioning) systems have a major impact on energy usage. Proper selection, installation, operation and maintenance of HVAC systems can yield substantial energy savings, help control seasonal spikes in energy usage and improve comfort and air quality in your commercial or industrial setting. We're offering a \$80/ton incentive for energy efficient replacements and \$250/ton incentive toward the purchase of qualified VRF and Dual Fuel Heat Pumps.



Thermal Ice Storage

Thermal ice storage systems work with conventional refrigeration equipment to produce cold water or ice. This chilled water or ice is stored in a tank and used to cool your building during peak hours, enabling you to shift electric cooling operations to off-peak hours, saving money and reducing peak demand. Our incentives can help offset your project's costs and are available at \$9 per ton hour for partial storage and \$11 per ton hour for full storage projects.
